  - a. Q reviews statement of financial position he will meet with Christina and Michelle next week; ACCBO money received (\$25,000 influx)
  - b. - 4. Property and planning committee Christina
  - a. Albright Church debate diocese signed agreement with developer for one-story retail
    - i. Parishioners disagree with this sale/use
    - ii. Historic designation denied by PA Supreme Court on a legal technicality bill reintroduced in City Council by Deb Gross to try to re-do historic designation
    - iii. Christina suggests trying to do a community meeting with other groups around historic designations
    - iv. Christina operating under assumption that BDC wants historic buildings to be preserved
  - b. St. Joe's Church ceasing operation as meeting space; parking lot under City control
    - i. Is historically designated; building itself is safe from demolition
  - c. No update on hotel we want first floor retail, City says no mechanism at this point
    - i. Interacting with Zoning
  - d. Groceria Italiana is closing on Saturday- Christina trying to get a meeting with them
  - e. Sugar and Smoke concept restaurant in former Del's/Jabo's location
  - f. ShurSave meetings and conversations ongoing with Milhouse
    - i. Working to convene planning meeting for the whole intersection (Oct/Nov)
    - ii. Need/desire to work on a Community Master Plan for Bloomfield
  - g. Morrow Park development is up for sale
  - h. Penn and Main liquor license application very new explanation by Christina of our liquor license transfer process
  - i. Baum Center Initiative meetings third Tuesday every month at 6 pm at Church at corner of Center and Aiken (1<sup>st</sup> United Methodist)
- 5. Housing Committee Christina



- a. Meeting more than monthly to roll out a housing survey for Bloomfield should be out early next week and continue over about 2 months
  - i. Multiple community groups are supporting the survey

- Explaining what PULSE is; new fellow (Sam) starting in September
- Collected data on Bloomfield Bridge/Liberty Avenue intersection
- Work on community process around new development
- Extensive business outreach surveys from over 100 businesses to try to determine future needs of businesses
  - Vacancies large priority
  - o Businesses looking less for large-scale events and more for individualized help
  - Three new businesses moved into Bloomfield via his help to find space Flower City Printmakers, Gryphon's Tea and Commonwealth Press
  - o Azorean Café helped get funding for storefront signage
  - o Businesses want to be engaged, understand what's going on in terms of new development
- Sustainable Pittsburgh Restaurants program helping food service businesses get sustainability designation
  - o Funding for staff time and for businesses
- Events
  - o networking breakfast with 45+ business owners
    - Will try to repeat every few months
  - Possibility of food-based event along lines of South Side soup tour, Lawrenceville cookie tour, etc.
- Published business feature articles in The Bulletin
- Per Christina, David will be doing a final report/capstone paper
